Kraken is pleased to announce two new services available to owners:

1. The ability to receive Direct Deposit of Royalty Payments to their bank account instead of receiving payment by check; and
2. The ability to receive Owner Summary Statements by email instead of receiving the large paper statements.

Direct deposit of royalty by ACH payments offers multiple advantages over receiving payment by check:

- Payment is normally received in only one to two business days
- Convenience to owner of not having to make a trip to bank to deposit a paper check as payment is sent directly to the bank
- Additional security of receiving payment as a paper check can be intercepted or lost in the mail
- Payment will be sent directly to bank account even if owner is away from home or on vacation

Receiving Owner Summary Statement by email offers the following advantages:

- Owners do not receive large bulky packages in the mail
- Less storage space needed by owner
- Owner can print only pages of interest
- Owner has ability to use "Find" feature to quickly go to specific sections of the statement
- Environmentally friendly due to less paper and the need to burn fuels to deliver paper statements

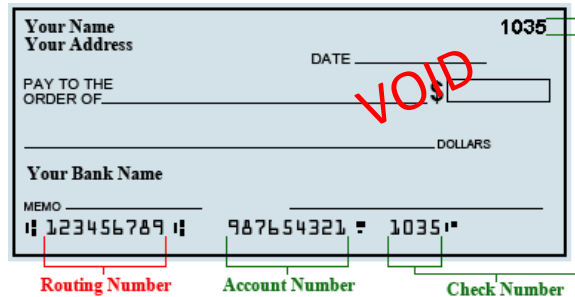
